Credit facility : Short-term loan in form of unsecured promissory note (at call)

Interest Rate : 2.85% per annum

draw down the loan amount

Nature of Contract : The Company will issue promissory note (at call)

Other Conditions : The Company can repay the principal before maturity

(5) The Characteristics and scope of the interest of the connected persons to enter to the connected transaction

This transaction is considered as the connected transaction regarding the receipt of financial assistance pursuant to the Notification of the Capital Market Supervisory Board No. Tor Jor. 21/2551 Re: Rules on Connected Transactions and the Notification of the Board of Governors of the Stock Exchange of Thailand entitled Disclosure of Information and Other Acts of Listed Companies Concerning the Connected

Transactions B.E. 2546 ("Connected Transaction Rules"), and its amendments.

In consideration of the size of the transaction under "Connected Transaction Rules", the size of transaction is larger than 0.03% but not more than 3% of net tangible assets of the Company according to the audited consolidated financial statement of the Company and its subsidiaries as at 31 December 2023 which

considered as a small transaction.

However, the size of previous related transaction occurred 6 months ago, therefore, the size of these transactions, all together was equal to 0.5543%; which was considered as a medium transaction so that the Company is required to get approval from the Board of Directors' meeting and disclose information to the

Stock Exchange of Thailand.

lending rate of financial institutions. Other loan covenants are more flexible comparing to financial

in stitutions.
